Foong Lian Chin Wanted for an Outstanding Warrant

Up to \$1,000 Reward Offered

October 19, 2020

San Diego County Crime Stoppers and investigators from the U.S. Marshals Fugitive Task Force are asking for the public's assistance to help in locating Foong Lian Chin who is wanted for an outstanding \$1,000,000 dollar warrant for a parental child abduction.

On 01/12/2019, Chin's ex-wife dropped off their two children (ages 7 & 8) with Chin, with the agreement that he was supposed to return them on 01/13/19. After failing to return the children, the mother called law enforcement to check Chin's address, there was no answer at his house. Attempts to reach Chin by phone were also unsuccessful.

On 01/16/2019, Chin's ex-wife was awarded full custody of their children by the Court. An arrest warrant for Chin was issued shortly thereafter. Investigators learned Chin had taken the children into Mexico, where he had property that he sold prior to the abduction. Additional information on Chin shows that he immigrated from Singapore in the 1980's and has since lived in New York, Southern California and Baja California. Their last know whereabouts were in Tijuana, MX.

Suspect's Description :

Chin is described as an Asian male, 47-years-old, 5'8" tall, with black hair, brown eyes and weighing 130 lbs.
